Focalizando o tema da etnicidade, o curso dirige sua atenção para o processo de construção de fronteiras e de identidades étnicas, procurando discutir os fatores que as modificam e determinam, como as teorias e concepções nativas, a competição por recursos, a hierarquia e estratificação entre grupos assimétricos, o estabelecimento de tradições e culturas regionais, a intervenção disciplinar do Estado.

Partindo de uma reconsideração de Barth, o curso busca, através dos autores selecionados e propostos, discernir algumas das principais vertentes teóricas cujos trabalhos constituem ou repercutem sobre o debate atual relativo a grupos étnicos, etnia e etnicidade.

Há uma ênfase intencional em favorecer o contato com textos que lidam com material empírico e com realidades históricas e culturais definidas. Com isso o curso pretende abordar a multiplicidade de usos e fundamentais via um quadro amplo de etnografias de contextos muito diferenciados, que devem ser interpretadas primordialmente como exercícios de aplicação de esquemas analíticos e hipóteses explicativas mais gerais.

Na expectativa de seu organizador, o curso se destina primordialmente a dar instrumentos para a pesquisa sobre alguns aspectos da existência atual dos povos indígenas, especialmente em seu relacionamento com o Estado-Nação e com agências e agentes das chamadas sociedades complexas. No entanto não há (nem, ao meu ver, caberia haver) uma intenção restritiva, uma vez que os textos selecionados freqüentemente operam com conceitos de mais largo espectro e a reflexão crítica avança por cotejos comparativos com outras modalidades de grupos sociais.
